UNFINISHED BUSINESS

- 1. DOWL update: provided by Wes Holden via Zoom.
- AWOS: Installation is expected to begin June 2nd, and take 3-5 days to complete.
- Beacon: The commissioners have determined that the best course of action for resolving the intrusive brightness of the new beacon is to relocate it from its current location 70' high on the cell tower to a lower, tilt-down pole. This will allow easy access to the beacon for all subsequent efforts to add a ring/baffle or other light remediation. DOWL and the manager will look for FAA approval and funding options.
- FAA: Representative will be visiting Lopez on Tuesday, June 17th.
 - 2. Pump-out boat: Commissioner Henriksen has successfully made needed repairs and is targeting launch May 20th 23rd,
 - 3. Cell Tower: Crane should arrive on-island May 13th, with installation work beginning May 14th.
